**Unfinished Business:**

- A. **Cares Grant-** Clerk Duncanson shared with the council that the EDA awarded \$99,662.24 in grants to four local business, Maple River School, Maple Mart, Optimal Performance Specialists, and Eagles Nest Child Care Center. The remaining Cares Funds have been used for police, public works, muni and city hall PPE, updating the Community Center Doors to be ADA accessible, and a washer for the Fire Department's turnout gear.

**New Business**

- A. **Resolution 70-10-20 Hiring Full Time Officer-** Chief Honsey is requesting to promote part-time officer Colter Killion to full-time. Councilor Froehlich asked if Colter lives in town, Honsey answered he does not, but per the city's personnel policy, he must have a response time of 30 minutes and might need to move a little closer. **Councilor Froehlich moved and Councilor Warner seconded to adopt Resolution 70-10-20 approving the status change of Officer Colter Killion from part-time to full-time. Roll Call Vote: Aye: Froehlich, Maslakow, Warner. Nay: none. Absent: Christian, Hollerich. Motion Carried.**

- B. Ordinance 153.121 Annexation by Ordinance-** Clerk Duncanson shared with the council that the 35.38 acres the school is requesting to be annexed into the city can be done by ordinance.
- C. Public Hearing-** The city will hold a public hearing on the proposed Ordinance 153.121 annexing the land for the new school at the Mapleton Fire Station Tuesday November 24<sup>th</sup>, 2020 at 7pm. Clerk Duncanson noted that abutting property owners will be invited directly, but the meeting is open to all interested citizens.
- D. Request for Street Closure-** The Mapleton Fire Department is requesting to close the block in front of Maggie J's between 1<sup>st</sup> Ave NE and 2<sup>nd</sup> Ave NE on October 25<sup>th</sup> to accommodate outdoor seating during their burger bar fundraiser. Councilor Froehlich noted that outdoor seating is weather permitting, but they want the permit just in case. **Councilor Froehlich moved and Councilor Warner seconded to close the block between 1<sup>st</sup> Ave NE and 2<sup>nd</sup> Ave NE in front of Maggie J's on October 25<sup>th</sup> for the Fire Department Burger Bar. Roll Call Vote: Froehlich, Maslakow, Warner. Nay: none. Absent: Christian, Hollerich. Motion Carried.**
- E. School Petition-** Clerk Duncanson shared with the council that the Maple River School Superintendent Dan Anderson signed the petition to annex the land into the city for the new school by ordinance.

Councilor Froehlich moved and Councilor Warner seconded to adjourn the meeting. All present voted in favor thereof. Motion carried. Councilor Maslakow adjourned the meeting at 7:15 p.m.
